
EXTENSION OF THE WATER TRANSMISSION PIPELINE AND DISTRIBUTION NETWORK AT NGOGWA-KITWANA

Invitation for Bids

1. This Invitation for Bids follows the General Procurement Notice for this Project which appeared in Development Business,
2. The Kahama Town Council has received financing from Development Partners and the Government of United Republic of Tanzania towards the cost of the **Extension of the water transmission pipeline and distribution Network at Ngogwa-Kitwana Villages** and intends to apply part of the portion of the funds to cover eligible payments under the contract for which this invitation for Bid is issued.
3. The Kahama Town Council has now invites sealed bids from eligible and qualified Piped system and Civil works contractors registered or capable of being registered with CRB in class Two (2) and above or specialised contractors in civil works given and signed by CRB for carrying out the **Extension of the water transmission pipeline and distribution Network at Ngogwa-Kitwana Villages** with the following activities: -
 - Excavate, supply of Steel and PVC pipes and lay in trenches and backfill pipes for transmission line with total length of 14,897m.
 - Excavate, supply of HDPE and PVC pipes and lay in trenches and backfill pipes for Distribution networks line with total length of 7,568m.
 - Construction of storage Tanks, On the ground tank and raised tank
 - Supply and install valves, fittings and specials.
 - Excavate for and construct pipeline manholes with internal diameters 1,000mm x 800mm x 1,000mm
 - Excavate for and construct pipeline thrust blocks and markers, air valves, Washouts and gate valves markers
 - Construct two taps domestic points with soak way pits.
 - Construct Cattle troughs with all fittings

4. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Public Procurement Act, No. 7 of 2011 and Public Procurement (Amendment) Act of 2016 and the Public Procurement (Goods, Works, Non Consultancy Service and Disposal of Public Assets by Tender) Regulations – Government Notice No. 446 of 2013 and Public Procurement (Amendment) Regulation of 2016 and are open to all eligible bidders.
5. Interested eligible Bidders may obtain further information from and inspect the Bidding Documents at the office of the **Secretary of Tender Board, Kahama Town Council, P. O. Box 472 - Kahama**, Tanzania, From 7:30 am to 3:30 pm Monday to Friday inclusive except on public holidays.
6. A complete set of Bidding Documents in English, in hard copy and additional sets may be purchased by interested Bidders on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of TZS 100,000 (Tanzanian shilling one hundred thousand) or its equivalent. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to the **Town Director, Kahama Town Council, P. O. Box 472, - Kahama**.
7. All bids in one original plus Two copies properly filled in, and enclosed in plain envelopes written on top of that envelope **Extension of the Water Transmission Pipeline and Distribution Network at Ngogwa-Kitwana Villages TENDER NO: - LGA/155/2018/19/WSDPII/W/02** must be delivered to the address, **Secretary of Tender Board, Kahama Town Council, P.O BOX 472 - KAHAMA** at or before **11:00** local times on **Tuesday , 30/10/2018** Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend in the opening ceremony at **Kahama Town Council Hall**, allocated at **Boma Road** in **Kahama Town** on their own cost.
8. Late bids, portion of bids, electronic bids, and bids not received, bids not opened at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
