**Invitation for Tenders**

1. Buzwagi Gold Mine has set aside funds for the operation of Kahama Municipal Council for the financial year 2022/2023. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for construction of Malenge Irrigation Scheme located at Isagehe ward in Kahama Municipal Council.
2. Kahama Municipal Council, P.O.Box 472 Kahama now invites Tenders from eligible Contractors registered with the Contractors Registration Board (CRB-Tanzania) in Class Four (IV)(Civil) and above for construction of Malenge Irrigation Scheme. Each Lot shall be treated independently as a separate Tender.
3. Tendering will be conducted through National Competitive Bidding specified in the Public Procurement Regulations, Government Notice No.446 of 2013 as amended and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
4. Interested eligible Tenderers may obtain further information and inspect the Tendering Documents at the office of the Secretary of the Tender Board, Kahama Municipal Council, P.O.Box 472 Kahama from 7:30 am to 3:30pm on Mondays to Fridays inclusive except on public holidays.
5. A complete set of Tendering Document(s) in English may be purchased by interested Tenderers upon payment of a non-refundable fee of Tanzanian Shillings one hundred thousand (100,000.00) only. Payment should be by **Control Number** through Banks or Banks' Agency, payable to the Municipal Director, Kahama Municipal Council.

6. All Tenders must be accompanied by a Tender security in an acceptable form in the amount of Tanzanian Shillings ten million (10,000,000.00) Only.
7. All Sealed Tenders in one original plus two copies, properly filled in, and enclosed in envelopes must be delivered to the Secretary of the Tender Board, Kahama Municipal Council, P.O.Box 472 Kahama at or before 10.30 hrs, On Monday, 05<sup>th</sup> December, 2022. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at Kahama Municipal Council Conference Hall.
8. Tenderers are advised to visit the site as per instructions stated in the Tender Data Sheet.
9. Late Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
